Premier Volleyball Academy Code of Conduct

THE FOLLOWING ACTIONS ARE PROHIBITED:

1. Possession, consumption or distribution of alcohol and/or tobacco on Premier Volleyball Academy premises at any time.
2. Physical damage to any part of any facility or theft of items from any room, gym space, or other person.
3. Possession of fireworks, ammunition, firearms, or other weapons or any item or material which by commonly accepted practices and principles would be a hazard or harmful to other persons at any time.
4. Any action considered to be an offense under Federal, State or local law ordinances.
5. Conduct which is inappropriate as determined by comparison to normally accepted behavior and also actions that will be detrimental to Premier Volleyball Academy LLC, participants, spectators or employees.
6. Physical or verbal intimidation of any individual.

Premier Volleyball Academy Disciplinary Policy

Minor misbehavior (e.g. not following facility rules or staff directions) will subject the violator to be declared ineligible for membership to Premier Volleyball Academy LLC for duration of time to be determined by the owner.

Major misbehavior (e.g. verbal or physical abuse of a child, sexual harassment, damage in or to the facility) may subject the violator to lifetime ineligibility at Premier Volleyball Academy LLC.
